COURSE DESCRIPTION

Fundamentals of algebra; polynomial, rational, exponential, and logarithmic functions, their graphs and applications; systems of equations. Credit may not be received for Math 126 if credit has already been awarded for Math 128 or higher.

PREREQUISITE

ACT 22, SAT 500, or Math 096 C/S

CORE OBJECTIVES

This course satisfies the university core mathematics requirement and meets the Core Objective CO2 Quantitative Reasoning: Students will be able to apply quantitative reasoning and mathematical analysis methodologies to understand and solve problems.

STUDENT LEARNING OUTCOMES

Upon completion of this course, a student will be able to graph rational functions, solve equations involving exponential and logarithmic functions, and solve inequalities involving rational functions.

TOPICS COVERED

Function notation, domain and range of a function; Properties of functions: increasing/deceasing, relative max/min, symmetry; Graphing functions: polynomial, rational, exponential, logarithm; Applications of functions: absolute max/min of quadratic functions; Solving polynomial and rational inequalities; Roots/zeros of polynomials; Composition of functions; Inverse functions; Applications of exponential and logarithmic functions;

Solving systems of equations; Imaginary numbers; Circles

Homework (15%): All homework assignments are to be completed on Pearson's MyMathLab online at www.mymathlab.com. Due dates will be posted online (HW assigned weekly, typically due Wednesdays at 11:59pm). It is your responsibility to keep up with the homework and due dates. You may work on your homework after the due date with a 30% penalty until midnight of the day before the next exam. You are allowed to work on homework with your classmates, a tutor, or in the math center. Getting help on homework is encouraged and is not considered cheating.

Quizzes (10%): There will be 11 quizzes given in recitation sections on Fridays. See course schedule for details. These will be done on MyMathLab online, just as your homework is. I will drop your two lowest quiz scores at the end of the semester.

Midterm Exams (45%): Three midterm exams will be given during the semester. See the course schedule for details.

Final Exam (30%): There will also be a cumulative final. Further details on the mid-term and final exams will be provided closer to the time of the exams.

Early/Late/Make-up Work: There will be no make-ups for exams, except for University-approved reasons. You must let the instructor know about any medical issues on the day of the exam, or if you are unable to do so, as soon as possible.
